SUMMARY

Transport and deliver goods and raw materials over land to and from manufacturing plants, retail, and distribution centers while operating a tractor-trailer. Possess a great deal of physical and mental stamina. Thrives working long hours on the road and can consistently ensure safe and accurate deliveries. Willing to stay on the road a week at a time. Must be detail-oriented, efficient, and maintain a clean driving record. Communicate with dispatch daily and when needed. Report all incidents or accidents encountered on the road.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following. Other duties may be assigned.

- Fully understand how to operate and safely drive your assigned vehicle
- Make safety a priority at all times and use all safety equipment provided
- Transport finished goods and raw materials over land from place of origin to assigned destination
- Pick-up loads and organize goods in an ordered, logical manner
- Ensure load contents are properly secured to prevent breakage or damage
- Responsible for loading and unloading
- Obtain signatures or warehouse scans to confirm and complete deliveries for customers
- Planning routes and meeting delivery schedules
- Communicate with dispatch as needed
- Document and log driving/on-duty/off-duty/detention/sleeper berth periods, miles driven, and retain bills of lading, fuel, toll, scale receipts.
- Comply with truck driving rules and regulations (FMCSA, DOT, State, etc.) as well as with company policies and procedures
- Obey all applicable traffic laws and drive according to the weather/road conditions
- Maneuver trucks into loading or unloading positions
- Collect and verify delivery instructions
- Inspecting vehicles for mechanical items and safety issues and perform preventative maintenance.
- Report defects, accidents or violations
- Always ensure vehicle is kept clean

REASONING ABILITY

Has constant contact with dispatch. Contact with customers, brokers, and dock employees as needed. Will also engage in contact with law enforcement for vehicle inspections or at other times as necessary.

Maintain a valid Commercial Driver's License (CDL) with hazmat and tanker endorsement. Maintain a current required CDL medical certificate.
